Now under The Haryana Registration and Regulation of Societies (Amendment) Act 2013, Para 2(ii) (5), it has been provided that any society may get itself de-registered under the present Act and get itself registered under The Indian Trust Act 1882 (Central Act 2 of 1882). Under the provision of the Societies (Amendment) Act 2013, the general body of the Society i.e. 'Shiksha Parishad Gurukul Matindu' has resolved through a 'special resolution' that the Society should be de-registered and Trust should be formed under the Indian Trust Act 1882. Accordingly, the Society has been de-registered under the provisions of the Haryana Societies (Amendment) Act 2013.


It has been resolved that the main structure of the Society shall remain unchanged on formation of the Trust. All movable, immovable properties, all assets and liabilities including debts, credits, reserve funds etc. shall now vest in the Trust. All agreements/deals done shall be binding on the Trust. The Trust will be working with the similar aims and objectives as that of the Society. Following persons who are active members of the Society are nominated to be the trustees of the Trust for managing the working of the Trust for achievement of aims and objectives in accordance with the Memorandum of Association and bye-laws:-

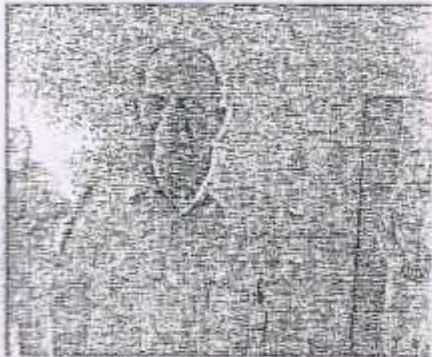

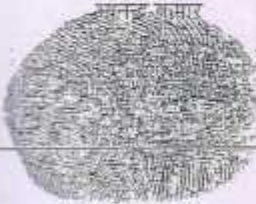
